**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILLBRAE APPROVING
THE REVISED SEWER SYSTEM MANAGEMENT PLAN**

WHEREAS, On May 2, 2006, pursuant to its authority under California Water Code §13263, the State Water Resource Control Board (SWRCB) adopted the Statewide General Waste Discharge Requirements (WDR) to regulate sanitary sewer wastewater collection systems. The WDR applies to all public collection system agencies in California that own or operate collection systems with more than one mile of sewer lines that convey untreated wastewater to a publicly owned treatment facility. One of the many requirements of the WDR is that each agency prepare, certify, adopt and implement a Sewer System Management Plan (SSMP). In addition, the City is required to audit the SSMP every two years from the original adoption date by evaluating the effectiveness of the implementation program. The City is required to review and revise the SSMP at least every five years or earlier when significant changes are made to the SSMP; and

WHEREAS, on July 14, 2009, City Council adopted Resolution No. 09-45 approving the SSMP; and


WHEREAS On September 9, 2013, the SWRCB Executive Director issued final revised Monitoring and Reporting requirements for the WDR. The major changes made by these MRP revisions that have now been included in the revised Millbrae SSMP include:

1. Increasing the spill reporting categories for sanitary sewer overflows (SSO) to three from two.
2. Reduces the SSO notification requirements to a single call.
3. Requires an agency specific Water Quality Monitoring Plan and Technical Report outline for SSOs greater than 50,000 gallons.
4. Streamlines the information that must be reported to the State SSO reporting system for small and medium SSOs.
5. Requires enhanced recordkeeping requirements for SSO activities.
6. Requires electronic submittal of the adopted SSMP to the State if not publicly available on the City website.
7. Requires an agency to maintain an up-to-date list of responsible officials.
8. Eliminates the requirement for certification of private sewer lateral overflows.
9. Requires that certain supporting documents be appended to the SSMP including SSMP audits, SSMP adoption documents and an SSMP change log to establish all dates and changes made to the SSMP along with the persons authorizing those changes; and

WHEREAS, the SSMP is a document that describes the activities the City uses to manage its sanitary sewer collection system effectively and to reduce sewer overflows. The intent of the SSMP, as required by the WDR, is to implement a formalized asset rehabilitation, operation, and maintenance program for the City collection system. The current five year review and revisions to the 2010 SSMP have also included an update to the historical performance results from the collection system operation since the new SWRCB regulations in 2006 and recognize and report on certain aspects of the City's obligations under its November 15, 2010 Consent Decree with Baykeeper. Additionally, a broadened system description, updating of actual collection system program changes since 2010 and revised short and long term capital planning have been added to this Revised SSMP.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Millbrae to approve the Revised Sewer System Management Plan.
