Terms and Conditions	<ul style="list-style-type: none">• Applicant must be a resident of Millbrae or have an active Millbrae business license. Residents must include a copy of a utility bill as proof of residency. Commercial landscapers must provide an active Millbrae business license.• Single incentive permitted per residential household and Millbrae business license. Applications must be submitted within 90 days of electric leaf blower or string trimmer equipment purchase date.• Applicants must provide a copy of the original equipment receipt and a photo of the equipment or equipment box that shows it matches with the receipt.• Incentives are distributed on a first-come first-served basis and are subject to availability of funds. Incentives may take several weeks to process.• Incentives will be issued as a check delivered to the address listed in the application.
