**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILLBRAE
AWARDING A CONSTRUCTION CONTRACT TO DW NICHOLSON FOR THE
SODIUM HYPOCHLORITE AND COMPRESSED AIR SYSTEM IMPROVEMENT
PROJECT AT THE MILLBRAE WATER POLLUTION CONTROL PLANT**

WHEREAS, on June 9, 2015 City Council adopted Resolution No. 15-24 approving the Fiscal Year 2015-2016 budget which includes \$275,000 in Capital Improvement Program funding for improving the sodium hypochlorite dosing system and the compressed air system at the Millbrae Water Pollution Control Plant (WPCP); and

WHEREAS, on July 25, 2015, the City published a Notice to Bidders inviting interested bidders to submit their sealed bids for the project; and

WHEREAS, on August 11, 2015 at 2:00PM City Clerk received one bid and publicly opened and read the bid; and

WHEREAS, the single bid was submitted by DW Nicholson in the amount of \$192,800; and

WHEREAS, DW Nicholson was the prime contractor on the Grease Receiving Project at the WPCP in 2005 and the City's experience with this Contractor on that project was a good one; and

WHEREAS, staff recommends that the City Council award the contract for these system improvements at the WPCP to DW Nicholson.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Millbrae hereby authorizes the award of a construction contract to DW Nicholson in the amount of \$192,800 for the sodium hypochlorite dosing system and compressed air system improvement project at the Millbrae Water Pollution Control Plant; and

BE IT FURTHER RESOLVED that the City Manager is authorized to execute the construction contract with DW Nicholson in the form provided in the Contract Documents.
