**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILLBRAE WAIVING
THE COMPETITIVE BID PROCESS AND AWARDING
A SOLE SOURCE CONTRACT TO ANDRITZ SEPARATION FOR THE
REHABILITATION OF THE DEWATERING SYSTEM AT THE MILLBRAE WATER
POLLUTION CONTROL PLANT**

WHEREAS, On June 9, 2015, City Council adopted Resolution No. 15-24 approving the City's Fiscal Year 2015-2016 Budget which includes a Capital Improvement Program budget with a \$400,000 project for the rehabilitation of the existing dewatering system at the Millbrae Water Pollution Control Plant; and

WHEREAS, the existing dewatering system at the Millbrae Water Pollution Control Plant is a proprietary system custom built by Andritz Separation in 1990 and no other firms can supply the components and parts to rehabilitate the system with the confined space available for this system and for these reasons Andritz Separation represents the sole source from which the City can obtain the work and prices required for the dewatering system; and

WHEREAS, plant staff has been working with Andritz Separation to determine the scope of repair and rehabilitation that is needed; and

WHEREAS, Andritz Separation provided a proposal to overhaul and rehabilitate the existing dewatering system in the total amount of \$349,200 inclusive of all labor costs and applicable taxes.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Millbrae waives the competitive bid process and awards a sole source contract to Andritz Separation in the total amount of \$349,200 to rehabilitate the existing dewatering system at the Millbrae Water Pollution Control Plant; and

BE IT FURTHER RESOLVED that the City Council of the City of Millbrae authorizes the City Manager to execute the contract with Andritz Separation.
