

**ORDINANCE NO. 741**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MILLBRAE  
AMENDING SECTIONS 4.90.090 AND 4.90.100 IN CHAPTER 4.90 IN THE MILLBRAE  
MUNICIPAL CODE REGARDING ALARM SYSTEM PERMIT REQUIREMENTS  
AND RELATED FEES**

The City Council of the City of Millbrae does hereby ordain as follows:

**SECTION 1. AMENDMENT OF SECTION 4.90.090.** The title and language of Section 4.90.090 in Chapter 4.90 of the Millbrae Municipal Code is hereby amended to read as follows:

**4.90.090 Alarm System Fee Schedule.**

The user of an alarm system shall pay such charges as may be established by resolution of the City Council. The fee schedule for alarm systems will set forth the amount and manner of payment of alarm system permit fees, false alarm fees, and such other fees as may be deemed necessary and appropriate to support the costs to manage and provide the permit program and related services that benefit users.

**SECTION 2. AMENDMENT OF SECTION 4.90.100.** The language of Section 4.90.100 in Chapter 4.90 of the Millbrae Municipal Code is hereby amended to state as follows:

**4.90.100 Permit.**


It shall be required that any alarm system installed, possessed, operated, used, serviced or maintained on any premises or property within the City shall have a valid, unrevoked and unexpired permit therefor issued in accordance with the provisions of this chapter and no alarm business or alarm agent shall make operable, service, maintain or repair any such alarm system for which there is no valid, unrevoked and unexpired permit issued by the City.

**SECTION 3. EFFECTIVE DATE; PUBLICATION.**


This ordinance shall be in full force and effect thirty (30) days from and after its passage. Within fifteen (15) days of its enactment, this ordinance shall be published once in a newspaper of general circulation published in the County of San Mateo and circulated in the City of Millbrae.
