**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILLBRAE  
MODIFYING THE GEOGRAPHICAL BOUNDARIES OF THE PREFERENTIAL  
PARKING PERMIT PROGRAM TO INCLUDE THE HEMLOCK  
AND BAYSIDE MANOR NEIGHBORHOODS**

**WHEREAS**, in 2005, the City Council adopted Chapter 4.80 of the Millbrae Municipal Code, which recodified the City's Preferential Parking Permit Program (Program); and

**WHEREAS**, Section 4.80.050 of Millbrae Municipal Code enables the City Council to add new areas to the Program by resolution; and


**WHEREAS**, parking in the Hemlock and Bayside Manor neighborhoods has become very limited due to patrons and employees of nearby businesses parking in the area for extended periods; and

**WHEREAS**, residents in the Hemlock and Bayside Manor neighborhoods have requested to be included in the Program; and


**WHEREAS**, staff has reviewed the parking conditions in the Hemlock and Bayside Manor neighborhoods, agrees that parking has increasingly become more difficult due to the recent opening of a new business, and recommends that the City Council include the Hemlock and Bayside Manor neighborhoods within the Program.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Millbrae hereby authorizes expansion of the Preferential Parking Permit Program to include the Hemlock and Bayside Manor neighborhoods and hereby adopts the attached map.

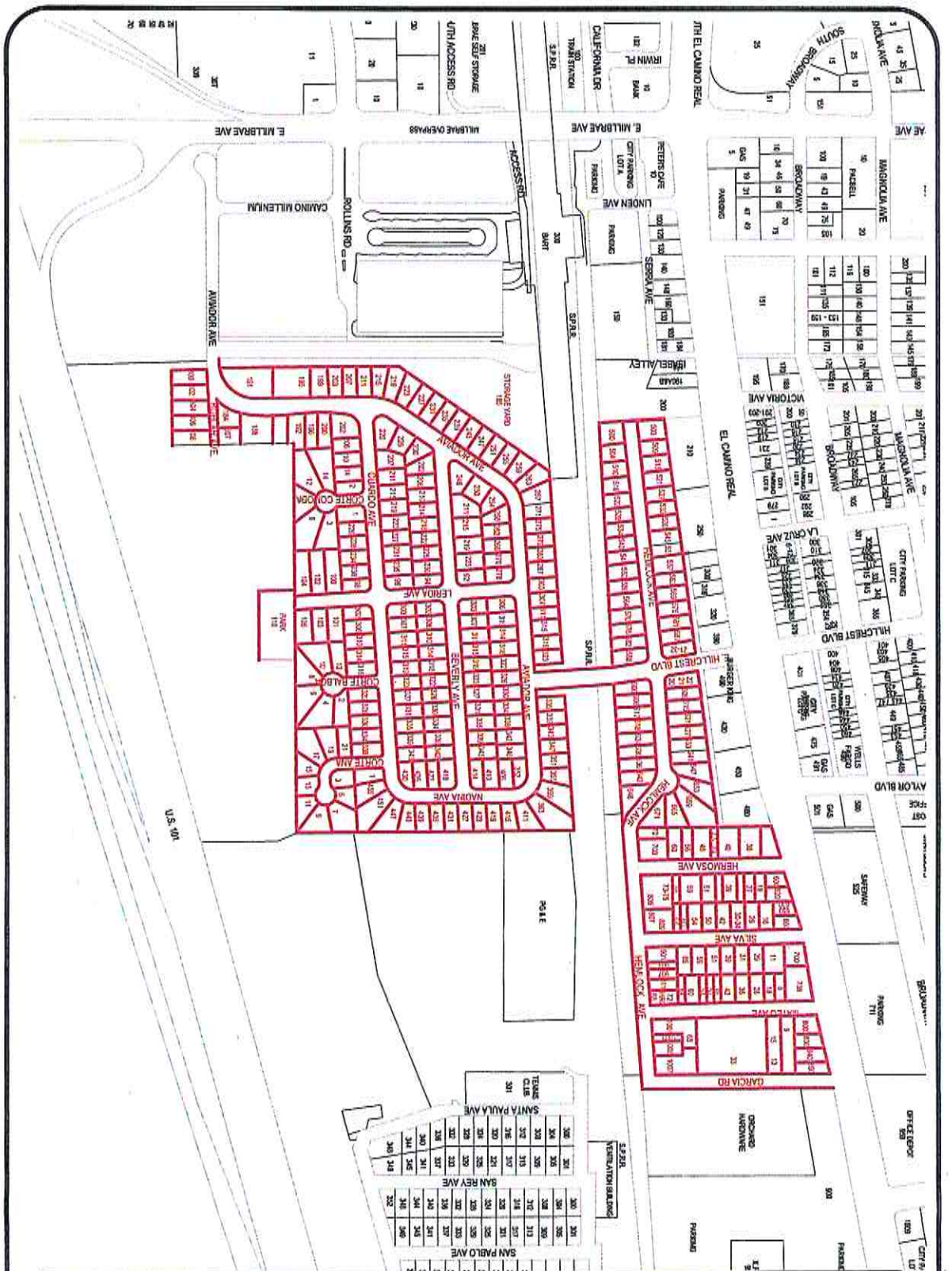
