**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILLBRAE AWARDING
A CONSTRUCTION CONTRACT TO PACIFIC TRENCHLESS, INC. IN THE
AMOUNT OF \$1,073,220 AND
APPROVING THE FIRST ADDENDUM TO AGREEMENT WITH CSG
CONSULTANTS IN THE AMOUNT OF \$94,015 FOR THE 2014 SANITARY SEWER
IMPROVEMENT PROJECT**

WHEREAS, on May 28, 2013 the City Council adopted Resolution No. 13-22 approving the Fiscal Year 2013-2014 Capital Improvement Program budget, including a budget of \$1,400,000 for sanitary sewer collection system rehabilitation; and

WHEREAS, on January 28, 2014 the City Council adopted Resolution No. 14-08 approving a professional services agreement with CSG Consultants in the amount of \$70,850 to prepare the contract bid documents for the 2014 Sanitary Sewer Improvement Project; and

WHEREAS, the City published a Notice to Bidders soliciting sealed bids and four bids were received by the City Clerk on or before 2PM on July 1, 2014; and

WHEREAS, Pacific Trenchless, Inc. is the apparent responsive and responsible low bidder with a bid of \$1,073,220; and

WHEREAS, the project requires the support of additional design and construction management services and staff has negotiated an amendment to the agreement with the project design consultant, CSG Consultants, in the amount of \$94,015 to provide such additional design and construction management services; and

WHEREAS, there are funds sufficient to cover the cost of the project.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Millbrae hereby awards a construction contract to Pacific Trenchless, Inc. in the amount of \$1,073,220 for the 2014 Sanitary Sewer Improvement Project; and

BE IT FURTHER RESOLVED that the City Council of the City of Millbrae hereby approves the First Addendum to Agreement with CSG Consultants in the amount of \$94,015 for additional design and construction management services to support the project.
