**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILLBRAE  
AUTHORIZING THE CITY MANAGER TO ENTER INTO A MEMORANDUM OF  
UNDERSTANDING (MOU) WITH THE MID-PENINSULA BOYS AND GIRLS CLUB  
TO PROVIDE A PILOT PROGRAM FOR AFTER SCHOOL ACTIVITIES IN THE  
MILLBRAE COMMUNITY YOUTH CENTER (MCYC)**

**WHEREAS**, the renovation of the Millbrae Community Youth Center has been a long-term goal of the Lions Club and other service and community groups, the Millbrae Elementary School District, and the City of Millbrae; and

**WHEREAS**, after more than four years of dedicated work and collaboration among many stake-holders, the Millbrae Community Youth Center was transferred to the control and operation of the City of Millbrae on March 26, 2013; and

**WHEREAS**, the overarching purpose of the MCYC is to be a focal point of after-school programs while providing a safe and secure site where middle school students may participate in engaging and enjoyable programs that seamlessly blend academic enrichment and homework activities with recreation, arts and technology; and


**WHEREAS**, the Mid-Peninsula Boys and Girls Club has a long-standing record of success in providing and managing dedicated youth facilities where boys and girls may safely study, grow, and be an active part of life-affirming and enriching activities and has agreed to provide such sources and programs in the MCYC on a pilot basis; and

**WHEREAS**, the City has agreed to provide financial assistance to the Mid-Peninsula Boys and Girls Club for the pilot program to assist with staffing at a cost not to exceed \$50,000 for the duration of the pilot program; and

**WHEREAS**, the opening of the Millbrae Community Youth Center provides an additional rental venue for community youth groups and the City will establish a schedule of evening and weekend availability and hourly rates for the MCYC and adjust the schedule of rental rates for the Chetcuti Room to maintain consistency.

**NOW, THEREFORE BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF MILLBRAE** formally authorizes the City Manager to enter into a Memorandum of Understanding with the Peninsula Boys and Girls Club to provide a pilot afterschool program in the Millbrae Community Youth Center from January 6, 2014 through June 30, 2014.
