**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILLBRAE
DECLARING THE CANVASS OF RETURNS AND RESULTS
OF THE GENERAL MUNICIPAL ELECTION
HELD ON NOVEMBER 5, 2013**

WHEREAS, a General Municipal Election was held in the City of Millbrae on November 5, 2013; and

WHEREAS, the votes of that election have been received and canvassed, and the election returns have been ascertained, determined, and declared in all respects as required by law.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Millbrae as follows:

1. The City Clerk of the City hereby is directed to enter this Resolution on the Minutes of this Council meeting as a statement of the results of the General Municipal Election on November 5, 2013;
2. The total number of ballots cast in the City at said election was 3,592 ballots. No ballots were spoiled and not counted;
3. The list of candidates nominated for the two offices of City Council for a four-year term each to be filled at said election and the names of the candidates which were set forth in the petitions assembled and filed with the City Clerk, as required by law, and the number of votes cast in favor of each said candidates are listed in Exhibit A, attached hereto and incorporated herein by reference;
4. Anne Oliva and Reuben D. Holoher each received a proportion of all votes cast for the Office of City Councilmember for which each was a candidate, and said persons were thereby elected to said offices, each for a full term of four (4) years. The City Clerk is

hereby authorized to sign and deliver to each of the above-named persons a Certificate of Election to the designated offices and to administer to these persons the Oath of Office prescribed in the Constitution of the State of California.
