**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILLBRAE  
ALLOWING REDWOOD ENGINEERING TO WITHDRAW ITS LOW BID DUE TO  
MISTAKE, AWARDING A CONSTRUCTION CONTRACT TO RANGER PIPELINES  
IN THE AMOUNT OF \$654,800 FOR THE 2012-2013 SANITARY SEWER POINT  
REPAIR PROJECT, BID NO. 914, AND AMENDING THE FY 12-13 SANITATION  
ENTERPRISE FUND BUDGET BY \$719,800 FOR THIS CAPITAL PROJECT**

**WHEREAS**, the City solicited sealed bids for the 2012-2013 Sanitary Sewer Point Repair Project; Bid No. 914; and

**WHEREAS**, seven bids were received and publicly opened and read on August 14, 2012 at 2:00 pm; and

**WHEREAS**, the bids prices range from a low of \$360,325 to a high of \$1,024,000 while the engineer's estimate is \$461,000; and

**WHEREAS**, the apparent low bidder, Redwood Engineering, gave timely notice to the City of their desire to withdraw their bid due to a mistake in filling out their bid, which was demonstrated to be the case through examination of their bid work papers; and

**WHEREAS**, the City Attorney office has reviewed the request and found Redwood Engineering to meet all statutory standards for withdrawal of their bid due to mistake; and

**WHEREAS**, staff recommends awarding a construction contract to the next low bidder, Ranger Pipelines for \$654,800, whose bid meets the requirements of the specification documents, and appropriate \$719,800 in the FY 12-13 Sanitation Enterprise Fund Budget for this capital project.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Millbrae that:

- (1) The bid submitted by Redwood Engineering on August 14, 2012 is withdrawn; and
- (2) A construction contract is awarded to Ranger Pipelines in the amount of \$654,800 for the 2012-2013 Sanitary Sewer Point Repair Project; Bid No. 914; and
- (3) FY 2012-2013 budget is amended to include an appropriation of \$719,800 to fund the 2012-2013 Sanitary Sewer Point Repair Project; Bid No. 914.
