**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILLBRAE
AWARDING A CONSTRUCTION CONTRACT TO CASEY CONSTRUCTION, INC. &
A CONSTRUCTION MANAGEMENT CONTRACT TO BELLECCI & ASSOCIATES,
INC. AND AMENDING FY12/13 WATER ENTERPRISE FUND BUDGET FOR THE
2012 WATER MAIN REPLACEMENT PROJECT: BID NO. 605**

WHEREAS, the City advertised the 2012 Water Main Replacement Project in a local newspaper inviting interested contractors to submit their respective bids for the subject project; and

WHEREAS, six bids were received and publicly opened and read on August 14, 2012 at 2:00PM; and

WHEREAS, the bids received range in price from \$323,650 to \$518,675 and the engineer's estimate is \$407,209; and

WHEREAS, the project will replace approximately 1,600 feet of existing water mains in Claremont Court, Dumont Court, Loyola Drive and Spring Valley Lane; and

WHEREAS, Casey Construction whose bid is in the amount of \$323,650 is recommended for award of the contract as this firm is determined to be the lowest responsible bidder; and

WHEREAS, the City's engineering consultant, Bellecci & Associates, Inc., will assist the City in managing the construction phase of the 2012 Water Main Replacement Project.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Millbrae that:

- (1) Casey Construction is awarded a construction contract in the amount of \$323,650; and
- (2) Bellecci & Associates, Inc. is awarded a consultant agreement for construction management services in the amount of \$89,500; and
- (3) The FY2012/2013 budget is amended to include an appropriation of \$520,245 for the 2012 Water Main Replacement Project; Bid No. 605.
