**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILLBRAE  
AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT  
WITH THE CITY OF SAN BRUNO FOR SHARED POLICE CHIEF SERVICES**

**WHEREAS**, the cities of Millbrae and San Bruno entered into an agreement for shared Fire Chief services in 2008 whereby the City of Millbrae Fire Chief provides Fire Chief services to San Bruno on an approximately half time basis; and

**WHEREAS**, the Fire Chief shared services arrangement has been successful and provided benefit to the cities of Millbrae and San Bruno in the form of significant cost savings to maintain delivery of necessary public safety services; and

**WHEREAS**, the City of Millbrae has a current vacancy in the Police Chief position and staff of both cities have evaluated the opportunity to expand the current shared services relationship with the establishment of a new agreement for Police Chief services; and

**WHEREAS**, the agreement provides for the Police Chief to perform budget administration, personnel management and supervision and all other typical duties and responsibilities of the Police Chief for the City of Millbrae on a half time basis; and

**WHEREAS**, the agreement provides for the City of San Bruno to provide Police Chief services to the City of Millbrae and for Millbrae to cover 50% of the costs for employment of the Police Chief in monthly installments; and

**WHEREAS**, during the term of the agreement the cities of Millbrae and San Bruno intend to further explore opportunities for expansion of shared Police services through the completion of a comprehensive shared Police services analysis and to jointly consider options developed through the analysis report.

**NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MILLBRAE** that the City Manager is hereby authorized to execute the Agreement for shared Police Chief services between the cities of Millbrae and San Bruno.


