

**RESOLUTION 10-25**

**APPROVE CONTRACT CHANGE ORDER NO. 4 WITH McGUIRE AND HESTER  
FOR EMERGENCY STORM DRAIN REPAIRS AT TAYLOR FIELD AND AMEND  
FISCAL YEAR 2009/2010 BUDGET TO APPROPRIATE FUNDING FOR THE  
REPAIRS**

**WHEREAS**, during construction of the Taylor Field Renovation project a large sink hole developed near the City's 22" storm line crossing under Taylor Field and video inspection of this 430 foot line revealed the line to be in very poor condition; and

**WHEREAS**, staff requested a proposal from McGuire and Hester who is the contractor renovating Taylor Field to repair the pipeline and such proposal at \$87,121 is deemed reasonable at an approximate cost of \$200 per lineal foot to replace 430 feet of storm line with new 22" pipe; and


**WHEREAS**, using McGuire and Hester should save costs on locating and protecting new irrigation piping installed in Taylor Field and minimize mobilization costs, and also minimize delays and potential added costs in completing the Taylor Field Renovation project; and

**WHEREAS**, staff recommends approving Contract Change Order No. 4 to the field's renovation project contract with McGuire and Hester to complete these emergency repairs and appropriating funding for this project in the Fiscal Year 2009/2010 Storm Drain Enterprise Fund.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Millbrae that Contract Change Order No. 4 to the field's renovation project construction contract with McGuire and Hester is hereby approved in an amount of \$87,121 for the emergency repair of storm drain piping under Taylor Field.

**BE IT FURTHER RESOLVED** that the Fiscal Year 2009/2010 budget be amended to appropriate \$114,121 in the Storm Drain Enterprise Fund for these repairs, including a contingency of \$22,000 plus \$5,000 for fencing repairs and other repair materials.
