**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILLBRAE  
AUTHORIZING CITY MANAGER TO AWARD A CONSTRUCTION  
CONTRACT TO ASBESTOS MANAGEMENT GROUP OF CALIFORNIA, INC.  
IN AN AMOUNT OF \$292,900 FOR THE FOR THE MILLBRAE COMMUNITY  
CENTER HAZMAT ABATEMENT AND SELECTIVE DEMOLITION PROJECT**

**WHEREAS**, on July 21, 2016, the Millbrae Community Center was destroyed by fire;

**WHEREAS**, staff prepared bid documents for the Millbrae Community Center Hazardous Materials Abatement and Selective Demolition Project (Project) and advertised a Notice to Bidders in nine Bay Area builder's exchanges and online plan posting services, as well as the City's website;

**WHEREAS**, on March 2, 2017 the City Clerk received two bids and publicly opened and read the bids;

**WHEREAS**, the apparent lowest, responsive and responsible bidder is Asbestos Management Group of California, Inc., who submitted a bid in the amount of \$285,000 and \$7,900 for Bid Schedule 1 and Bid Schedule 2, respectively, for a total amount of \$292,900;

**WHEREAS**, the bid documents stated that Bid Schedule 1 is the amount that is to be used in determining the low bid; and

**WHEREAS**, staff recommends that the City Council authorize the City Manager to award a construction contract in an amount of \$292,900, inclusive of both Schedule 1 and Schedule 2 for the Project.

**NOW, THEREFORE BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF MILLBRAE** hereby authorizes the City Manager to award a construction contract in the amount of \$292,900 to Asbestos Management Group of California, Inc. for the Community Center Hazmat Abatement and Selective Demolition Project.
