**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILLBRAE  
APPROVING A CONTRACT TO QUALITY PIPE SERVICES, INC. FOR THE  
2017 SANITARY SEWER MAINS CLEANING AND INSPECTION PROJECT  
NO. 141**

**WHEREAS**, on November 16, 2010, the City and San Francisco Baykeeper entered into a Consent Decree whereby the City agreed to inspect the entire sanitary sewer collection system by 2014; and

**WHEREAS**, in 2014 the City completed its sanitary sewer collection system and committed to transition the program to a long-term program whereby the City's entire collection system would be inspected every five-year cycle; and

**WHEREAS**, as part of the long-term inspection program, the City committed to inspect at least 11 miles of sanitary sewer mains in 2016; and

**WHEREAS**, the City published a Notice to Bidders inviting interested bidders to submit sealed bids to inspect the sewer mains; and

**WHEREAS**, on January 31, 2017, the City Clerk received five (5) bids and publicly opened and read the bids; and

**WHEREAS**, the lowest responsive and responsible bid was submitted by Quality Pipe Services, Inc. in the amount of \$177,388.00; and


**WHEREAS**, staff recommends that the City Council award the contract for the 2017 Sanitary Sewer Cleaning and Inspection Project to Quality Pipe Services Inc. in the amount of \$177,388.00 to clean and inspect 15 miles of sewer main lines in 2017; and

**WHEREAS**, staff also recommends that the City Council approve a project contingency of \$21,612.00 for the project to fund additional work as needed, including to cover project administration costs.

**NOW, THEREFORE BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF MILLBRAE** hereby authorized the award of a construction contract to Quality Pipe Services, Inc. in the amount of \$177,388.00 for the 2017 Sanitary Sewer Mains Cleaning and Inspection Project and establish a project contingency fund of \$21,612.00; and

**BE IT FURTHER RESOLVED** that the City Manager is authorized to execute the construction contract with Quality Pipe Services, Inc. in the form provided in the Contract Documents.
