**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILLBRAE  
AWARDING A CONSTRUCTION CONTRACT TO G. BARTOLOTTO AND  
COMPANY, INC. AND  
APPROVING THE PROFESSIONAL SERVICES AGREEMENT WITH CSG  
CONSULTANTS, INC. FOR THE VARIOUS STREETS AND ROADS  
PRESERVATION PROJECT NO. 112**

**WHEREAS**, on June 14, 2016 adopted the Resolution No. 16-13 approving the execution of a funding agreement with Caltrans for the pavement rehabilitation of Millbrae Avenue and Magnolia Avenue. This project will replace approximately two-thousand four hundred and fifty (2,450) linear feet of roadway surface to include base repairs, striping, markings, traffic loops, utility manhole adjustments and ADA curb ramp improvements; and

**WHEREAS**, a majority of the project work is to be completed in the evening and will require adequate staffing to support this work; and

**WHEREAS**, the City published a Notice to Bidders soliciting interested bidders to submit sealed bids for the project; and

**WHEREAS**, on January 31, 2017, the City Clerk received three (3) bids and publicly opened and read the bids; and

**WHEREAS**, the lowest responsive and responsible bid was submitted by G. Bartolotto and Company, Inc. in the amount of \$775,824; and

**WHEREAS**, staff recommends that the City Council award the contract for the Various Streets and Roads Preservation Project No. 112 to G. Bartolotto and Company, Inc. in the amount of \$775,824; and

**WHEREAS**, staff also recommends that the City Council approve a project contingency of \$120,000 to fund additional work as needed and to cover project administration costs; and

**WHEREAS**, the project requires the support of additional construction management services and staff has negotiated an agreement with the project design


consultant, CSG Consultants, in the amount of \$84,980 to provide such construction management services; and

**WHEREAS**, there are funds available in the Fiscal Year 2016-2017 budget which are sufficient to cover the cost of the project.

**NOW, THEREFORE BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF MILLBRAE** hereby awards a construction contract to G. Bartolotto and Company, Inc. in the amount of \$775,824 for the Various Streets and Roads Preservation Project No. 112; and

**BE IT FURTHER RESOLVED** that the City Council of the City of Millbrae hereby approves the Professional Services Agreement with CSG Consultants in the amount of \$84,980 for construction management services to support the project.
