**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILLBRAE
AWARDING A CONSTRUCTION CONTRACT TO D&D PIPELINES, INC. IN
THE AMOUNT OF \$1,043,800 FOR THE 800 BLOCK OF HILLCREST
DRAINAGE IMPROVEMENT AND AMENDING THE FISCAL YEAR
2017-2018 BUDGET TO INCLUDE AN APPROPRIATION OF \$1,252,560 FOR
THE PROJECT**

WHEREAS, the City prepared bid documents and issued a Notice to Bidders in early May inviting bids for the construction of approximately 1,000 linear feet of 24-inch reinforced concrete storm drain pipeline in the 800 Block of Hillcrest Boulevard; and


WHEREAS, on May 30, 2017 at 2:00 PM, the City Clerk Office received one single bid from D & D Pipelines, Inc. in the amount of \$1,043,800; and

WHEREAS, staff has evaluated the bid submitted by D & D Pipelines, Inc. and found the bid to be responsive and the bidder responsible.

NOW, THEREFORE BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF MILLBRAE awards a construction contract to D & D Pipelines, Inc. in the amount of \$1,043,800 for the 800 Block of Hillcrest Drainage Improvement Project, authorize the City Manager to sign an agreement with D&D Pipelines in the amount of \$1,043,800, and authorizes the City Manager to sign agreements and amendments for this project up to the amount of the project contingency (\$104,380).


BE IT FURTHER RESOLVED BY THE CITY COUNCIL OF THE CITY OF MILLBRAE amends the Fiscal Year 2017-2018 budget to include an appropriation of \$1,252,560 in the Storm Drain Fund for this project and authorizing a transfer from the General Fund to the Storm Drain Fund of up to \$1,252,560 for the 800 Block of Hillcrest Drainage Improvement Project
