**CITY OF MILLBRAE, COUNTY OF SAN MATEO

**RESOLUTION AWARDING A CONSTRUCTION CONTRACT TO
INTERSTATE GRADING AND PAVING, INC. AND APPROVING A
PROFESSIONAL SERVICES AGREEMENT WITH BELLECCI &
ASSOCIATES, INC. FOR THE 2017 PAVEMENT REPAIR PROJECT**

WHEREAS, On June 14, 2016, the City Council adopted Resolution No. 16-18 approving the budget for Fiscal Years 2016-2017 and 2017-2018 which includes \$1.5 million in funding related to roadway repair for each fiscal year; and

WHEREAS, the 2017 Pavement Repair Project will replace approximately 3,000 linear feet of roadway surface through standard asphalt removal with overlay and full-depth reclamation and will include base repairs, striping, markings, utility manhole adjustments and American with Disabilities Act (ADA) curb ramp improvements; and

WHEREAS, the City published a Notice to Bidders soliciting interested bidders to submit sealed bids for the project; and

WHEREAS, on June 13, 2017, the City Clerk received one (1) bid and publicly opened and read the bid; and

WHEREAS, the lowest responsive and responsible bid was submitted by Interstate Grading and Paving, Inc. in the amount of \$1,274,686, which is below the Engineer's Estimate of \$1,388,000; and

WHEREAS, staff recommends that the City Council award the contract for the 2017 Pavement Repair Project to Interstate Grading and Paving, Inc. in the amount of \$1,274,686; and

WHEREAS, the project requires the support of additional construction management and inspection services and staff has negotiated an agreement with the project design consultant, Bellecci & Associates, Inc., in the amount of \$103,856 to provide such construction management and inspection services; and

WHEREAS, staff also recommends that the City Council approve a project contingency of \$196,458 to fund additional work as needed and to cover project administration costs; and

WHEREAS, there are funds available in the Fiscal Year 2017-2018 budget and in Fund Balance for the Gas Tax Fund which are sufficient to cover the cost of the project.


NOW, THEREFORE BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF MILLBRAE hereby awards a construction contract to Interstate Grading and Paving, Inc. in the amount of \$1,274,686 for the 2017 Pavement Repair Project; and

BE IT FURTHER RESOLVED that the City Council of the City of Millbrae hereby authorizes the City Manager to sign a Professional Services Agreement with Bellecci & Associates, Inc. in the amount of \$103,856 for construction management services to support the Project.

BE IT FURTHER RESOLVED that the City Council of the City of Millbrae hereby authorizes an increase in the Gas Tax Capital Projects Budget for Fiscal Year 2017 – 2018 in the amount of \$75,000.


AND BE IT FURTHER RESOLVED that the City Council of the City of Millbrae authorizes the City Manager to execute both contracts and any contract change orders for up to \$196,458 (the amount of the project contingency).
