

ORDINANCE NO. 764

**CITY OF MILLBRAE, COUNTY OF SAN MATEO
STATE OF CALIFORNIA**

**ORDINANCE ADDING SECTIONS 4.15.310 and 4.15.320 TO THE MILLBRAE
MUNICIPAL CODE REGARDING ELECTRIC VEHICLE PARKING**

The City Council of the City of Millbrae does ordain as follows:

SECTION 1: ADDITION OF SECTION 4.15.310

Chapter 4.15 "Parking Regulations" is hereby amended to add Section 4.15.310, which read as follows:

4.15.310 Non Electric Vehicles Prohibited in Spaces Designated for Electric Vehicle Parking.

No person shall park or leave standing any vehicle which is not an electric vehicle in any space designated exclusively for electric vehicle charging. As used herein, the term "electric vehicle" means any motor vehicle registered to operate on California public roadways and that operates, either partially or exclusively, on electrical energy from the grid or an off-board source that is stored on-board for motive purposes. "Electric vehicle" includes, but is not limited to, battery powered electric vehicles, plug-in hybrid electric vehicles, neighborhood electric vehicles, and electric motorcycles.

SECTION 2: ADDITION OF SECTION 4.15.320

Chapter 4.15 "Parking Regulations" is hereby amended to add Section 4.15.320, which read as follows:

4.15.321 Restrictions on Parking Electric Vehicles in Designated Spaces.

No person shall park or leave standing any electric vehicle, as defined in Section 4.15.310, in any space designated exclusively for electric vehicle charging, for longer than 2 hours. The vehicle must be plugged in for charging while parked in such space.

SECTION 3: EFFECTIVE DATE: PUBLICATION


This Ordinance shall be in full force and effect 30 days after its passage. Within 15 days of its passage, a summary of this Ordinance shall be published once in a newspaper of general circulation in the City of Millbrae.
