RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILLBRAE
ACCEPTING THE 2017 SANITARY SEWER AT VARIOUS LOCATIONS
PROJECT AS COMPLETE AND AUTHORIZING THE FILING OF A NOTICE
OF COMPLETION WITH THE SAN MATEO COUNTY CLERK

WHEREAS, on July 25, 2017, the City Council adopted Resolution No. 17-36 awarding a construction contract to D'arcy & Harty Construction (Contractor) in the amount of \$2,784,100 for the 2017 Sanitary Sewer at Various Locations Project (Project) and approving a Project contingency of \$420,000; and

WHEREAS, a Notice to Proceed was issued to the Contractor in October 16, 2017 and Contractor began work soon after issuance of the Notice to Proceed; and

WHEREAS, Contractor has completed all contract work, including replacement of 10,268 linear feet of existing sanitary sewer main with new high-density polyethylene (HDPE) pipe, replacing or rehabilitating fifty-six (56) manholes, and replacing two-hundred thirty four (234) lower sewer laterals at various locations throughout the City; and

WHEREAS, four (4) Contract Change Orders totaling \$340,643 were executed to pay for additional work; and

WHEREAS, the total contract cost was \$3,124,743 which is \$79,357 below the total Project funding approved by the City Council on July 25, 2017; and

WHEREAS, staff performed the final inspection on the Project and determined all work has been satisfactorily completed with the Project plans and specifications; and

WHEREAS, staff recommends that the City Council accept the Project as complete and authorize the filing of a Notice of Completion with the San Mateo County Clerk.


