RECOMMENDATION:

Staff recommends that the City Council, by motion, approve a sponsorship in the amount of \$10,000 for the San Mateo County Sheriff's Activities League (SAL) 2019 Food Wine and Heroes event.

BACKGROUND:

The San Mateo County Sheriffs Activities League (SAL) is part of a Community Policing Philosophy that promotes police and community partnerships with a problem-solving approach that is responsive to the needs of the community. Programs offered in Millbrae include: soccer, mentoring, tutoring, and golf. The Food Wine & Heroes Event is a fundraiser to support activities to build relationships between deputies, youth, and families of San Mateo County and support programs which aid in prevention of juvenile delinquency, increase graduation rates, decrease obesity rates, provide a caring adult role model, and provide youth with tools to be successful in life. The sponsorship level of \$10,000 is titled a "Sheriff Sponsor" and includes: printing on all event materials, tickets to the event, and raffle tickets.

Last year the City of Millbrae supported this annual event with a \$10,000 contribution.

FISCAL IMPACT:

Sufficient funds are available in the Fiscal Year 2018 - 2019 budget for this request.
