**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILLBRAE
ACCEPTING THE 12 CORTE NUEVA SANITARY SEWER MAIN
RELOCATION PROJECT AS COMPLETE AND AUTHORIZING THE FILING
OF A NOTICE OF COMPLETION WITH THE SAN MATEO COUNTY CLERK**

WHEREAS, on July 25, 2017, the City Council adopted Resolution No. 17-38 awarding a construction contract to the lowest responsive and responsible bidder, EPS Inc., dba Express Plumbing (EPS), for an amount up to \$180,0000 for the 12 Corte Nueva Sanitary Sewer Main Relocation (Project); and

WHEREAS, after the Notice to Proceed was issued in January 2019, EPS discovered that there was an unpermitted retaining wall within the subject sanitary main that damaged the sewer pipeline; and

WHEREAS, the property owner and City Attorney negotiated a settlement agreement where the property owner, at its own cost, upgraded the retaining wall so that it would not impact the City's sewer pipe and compensated the City for all additional repair costs beyond the amount the City would have otherwise had to pay had the unpermitted retaining wall not been present; and

WHEREAS, EPS has successfully completed all contract work, including replacement/installation of approximately 160 linear feet of existing sanitary sewer main with new high-density polyethylene (HDPE) pipe; and


WHEREAS, Staff issued one (1) change order for elimination of two (2) sewer clean outs and extra work due to unforeseen soils condition; which resulted in a \$6,150 credit and final construction cost of \$68,700; and

WHEREAS, Staff performed the final inspection of the Project and determined all work has been satisfactorily completed with the Project plans and specifications; and

WHEREAS, Staff recommends that the City Council accept the Project as complete and authorize the filing of a Notice of Completion with the San Mateo County Clerk.

NOW, THEREFORE BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF MILLBRAE accepts the 12 Corte Nueva Sanitary Sewer Main Relocation Project as complete and authorizes the filing of the Notice of Completion with the San Mateo County Clerk.
