**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILLBRE
AWARDING A CONSTRUCTION CONTRACT TO G. BORTOLOTTI AND
COMPANY, INC. FOR THE 2019 PAVEMENT MAINTENANCE PROJECT IN
THE AMOUNT OF \$755,250 AND AUTHORIZING THE CITY MANAGER OR
DESIGNEE TO EXECUTE THE CONSTRUCTION CONTRACT AND CHANGE
ORDERS OR ADDENDA UP TO THE PROJECT CONTINGENCY AMOUNT OF
\$100,000**

WHEREAS, on June 12, 2018, the City Council adopted Resolution No. 18-34 approving the budget for Fiscal Years (FY) 2018-2019 and 2019-2020, and the Capital and Special Projects Five Year Plan for FY 2019 – 2023; and

WHEREAS, the budget includes \$1 million in funding related to roadway maintenance for fiscal year 2018-2019; and

WHEREAS, the 2019 Pavement Maintenance Project (Project) will include slurry seal resurfacing of approximately 540,000 square feet and replacement of all affected striping, markings traffic loops, utility (sewer/water) manholes and survey monuments at the following locations: Anita Drive, Henry Place, Helen Drive South, Helen Drive North, Lomita Avenue, Santa Florita Avenue, Santa Susana Avenue, Santa Teresa Way, Cypress Avenue, Rosalita Lane, Vista Court, and Broadway Avenue; and

WHEREAS, the City published a Notice to Bidders soliciting interested bidders to submit sealed bids for the Project; and

WHEREAS, on April 16, 2019, at 2:00 PM, the City received two (2) bids and publicly opened and read the bids; and

WHEREAS, lowest, responsive and responsible bid was submitted by G. Bortolotto & Company, Inc. (Bortolotto) in the amount of \$755,250, which is 2% higher than the Engineer's Estimate of \$739,900, and staff determined this difference to be reasonable and within acceptable range; and

WHEREAS, Staff recommends that the City Council award a contract to Bortolotto in the amount of \$755,250 for the Project; and


WHEREAS, Staff recommends that the City Council approve a project contingency of \$100,000 to fund administration costs, additional work such as unforeseen sub-surface site conditions or other unanticipated additional work required to complete the Project.

NOW, THEREFORE BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF MILLBRAE hereby awards a construction contract to G. Bortolotto & Company, Inc. in the amount of \$755,250 for the 2019 Pavement Maintenance Project; and

BE IT FURTHER RESOLVED that the City Council of the City of Millbrae authorizes a Project contingency in the amount of \$100,000 (approximately 13.5%) in order to address any unforeseen site conditions and/or additional work required to complete the Project; and

AND BE IT FURTHER RESOLVED that the City Council of the City of Millbrae authorizes the City Manager or designee to execute the contract and any change orders and addenda up to the Project contingency amount.
