**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILLBRAE
ACCEPTING THE HILLCREST BASIN SEWER REHABILITATION PROJECT
AS COMPLETE AND AUTHORIZING THE FILING OF A NOTICE OF
COMPLETION WITH THE SAN MATEO COUNTY CLERK**

WHEREAS, on July 10, 2018, the City Council adopted Resolution No. 18-46 awarding a construction contract to D'arcy & Harty Construction, Inc. (Contractor) in the amount of \$1,147,475 for the Hillcrest Basin Sewer Rehabilitation Project (Project) and approving a Project contingency amount of \$170,000; and

WHEREAS, a Notice to Proceed was issued to the Contractor on October 1, 2018, and work began work soon thereafter; and

WHEREAS, Contractor has successfully completed all contract work, including replacement of approximately 3,030 linear feet of existing 6-inch and 8-inch diameter sanitary sewer main with new high-density polyethylene (HDPE) pipe, lamp holes, lower laterals, cleanouts, manhole frames and covers, sewer flow control, and other improvement within Hillcrest Basin; and

WHEREAS, as part of the construction, the Contractor replaced additional pipes to properly align the sewer main, re-aligned lower laterals via open trench method that were not in compliance, and eliminated some planned work that were identified to be unnecessary, which resulted in credits to the City; and


WHEREAS, change orders totaling \$13,720 in credit were issued for changes in construction methods, realignment of sewer mains and lateral, as well as elimination of planned work that were identified to be unnecessary; and

WHEREAS, staff performed the final inspection on the Project and determined all work has been satisfactorily completed with the Project plans and specifications; and

WHEREAS, staff recommends that the City Council accept the Project as complete and authorize the filing of a Notice of Completion with the San Mateo County Clerk.

NOW, THEREFORE BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF MILLBRAE accepts the Hillcrest Basin Sewer Rehabilitation Project as complete and authorizes the filing of the Notice of Completion with the San Mateo County Clerk.
