**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILLBRAE
AUTHORIZING COLLECTION OF FISCAL YEAR 2019-2020 STORMWATER FEES
ON THE SAN MATEO COUNTY TAX ROLL**

WHEREAS, the Environmental Protection Agency, under amendments to the 1987 Federal Clean Water Act, imposed regulations that mandate local government control and reduce the amount of stormwater pollutant runoff into receiving waters; and

WHEREAS, under the authority of California Porter-Cologne Water Quality Act, the State Water Resources Control Board has delegated authority to its regional boards to invoke permitting requirements upon counties and cities; and

WHEREAS, the City of Millbrae established the Stormwater Enterprise Fund to generate revenue to fund the City of Millbrae Stormwater Program; and

WHEREAS, the City Council in 1994 adopted a fee schedule and amended the Millbrae Municipal Code to include Stormwater Fees and authorized the San Mateo County Tax Assessor to include and collect the Stormwater Fees previously established and currently in place for the Millbrae Stormwater Program on the County Tax Rolls; the fees are as follows:

Single Family Residential	\$ 25.66
Low Density Single Family Residential	\$ 91.60
Multi Family Residential	\$ 58.50
Commercial and Industrial	\$223.23

WHEREAS, each year the City Council is required to request the County Tax Assessor to include and collect the referenced fees with the County Tax Rolls and by this resolution, the City Council submits this request for Fiscal Year 2019-2020.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Millbrae that:

1. The City of Millbrae respectfully requests that all properties within the territorial limits of said City be charged the Fiscal Year 2019-2020 Millbrae Stormwater Fees in accordance with said charges stated above; and,

2. The City Clerk is hereby directed to forward a copy of this Resolution together with any other required information to the Clerk of the San Mateo County Board of Supervisors and the County Controller.
